

To amend or revise, that is the question...

Amending bylaws isn't supposed to be easy. Bylaws are a contract between the organization and its members, so you wouldn't want to be able to modify the terms any old time you feel like it. The CCPU Bylaws outline the process to amend in Article X. The criteria are straightforward: can be amended at any meeting by a 2/3 vote of those present and voting provided a notice of the proposed amendment has been given to members 10 days prior to the meeting the amendments will be considered. If previous notice requirement is not met, a unanimous vote is required to adopt.

Often proposed amendments target one aspect of the bylaws and inadvertent grammatical inconsistencies or ambiguities of intent may result. So, what does the bylaws committee do in those circumstances. Do we continue to amend? Do we continue to patch and correct the inconsistencies from previous amendments? How many are too many amendments to be considered? When is it time to stop amending and start revising? These are all questions the bylaws committee is currently pondering.

A bylaws revision is a major overhaul or wholesale replacement of the bylaws. It is usually done when there are too many changes to be made through the amending process. We are familiar with the straightforward process of amending bylaws. Let's review the revision process.

The notice requirements are the same as with amendments. The notice would include a complete set of restated bylaws. There is no scope of notice (See RONR p. 307, II. 28). Any and all changes to the proposed document can be made at the meeting itself. The revision committee would present a complete set of bylaws, and each Article and Section will be considered seriatim. Each is open to amendment, which requires a majority vote. If members decide to go further than the original committee and be more drastic, they are perfectly free to do so. If your board or members are sensible and thoughtful folks, this won't be a problem. But a faction could radically alter your organization on the spot, if they convince enough people of their views. A revision is adopted by the same vote that is required to amend the bylaws, two-thirds of those voting.

Bylaws can be like a dust magnet, and there may be an advantage to shake out the dust and restate the bylaws of CCPU. The bylaws committee welcomes your comments and suggestions.
