CCPU Standing Rules were amended in January of 2017, to have the provisional members pay their FSAP dues directly to CCPU. This allows for tracking of the payments made by our provisional members.

Per the CCPU Standing Rules:

4. DUES: annual Dues for regular members shall be ten (\$10.00) dollars for CCPU membership.
 - Section 1. Provisional members shall pay CCPU thirty-five dollars (\$35.00). CCPU shall remit twenty-five (\$25.00) of this amount per provisional member to FSAP in a timely manner to cover the provisional member's FSAP dues. Provisional members shall not make a separate payment to FSAP for their individual dues. Amended 1/12/2017
