I am pleased to let you know that Christine Sutherland is recovering nicely since her stroke. She is quarantined as we all are, and plans to work on her RP studies as her health improves.



Henry Martyn Robert, as the son of an accomplished minister, was headed for great things. During his lifetime, he was involved with a number of varied academic and social service commitments. He held a commission in the Army during the Civil War, utilizing his background in engineering. As such and after the war, he moved several times throughout the country and eventually became a general. His desire for order in meetings is legendary. The pamphlet he produced was originally self-published and could be carried in your pocket. While not the only book of self-

governing protocol, Robert's version has remained dominant in the U.S. Eventually *Robert's Rules* and subsequent editions became the family business, with the involvement of his daughter-in-law and grandson.

Bylaw Committee Report



The bylaws committee has been taking advantage of the COVID 19 motivated “stay at home” order to

meet weekly by conference call for the last 7 weeks.

During our discussions we have reviewed CCPU bylaws repeatedly to balance what happens in real-world practice at CCPU and the language NAP expects to see in the bylaws of its subordinate units.

The last newsletter article revealed the committee’s debate of whether to propose a revision or amendments to CCPU bylaws. The decision has been made to recommend a revision. There are too many proposed changes and tweaks to current wording to make individually proposed amendments realistic.

It never occurred to me before, but there are similarities between CCPU bylaws and RONR. The first edition of RONR had 176 pages while the 11th edition has 716 pages. The current CCPU bylaws have around 6 pages and the proposed revision plans to be around 8 pages. With RONR, each edition refines and clarifies its interpretation to answer newly arising questions.

The committee believes CCPU bylaws also need to clarify and refine certain areas. To give some examples, the bylaws committee thinks that adding the following provisions would be helpful:

- Officer duties;
- Committee duties;
- Clarify committee appointment process;
- NAP says we need to provide for an annual budget and an audit;
- Add a section (and a new committee) on Finance, to include fiscal year, audit, budget, when dues are due;
- Add a nominating committee, its election and its duties;
- In the event of an emergency, authorize the executive board to make meeting decisions and to take certain actions.

The revision process will be a super-workshop for CCPU. It is the committee’s intent that reviewing the revision will be a slow and deliberate process, involving member participation. Members will play an active part as we hone the proposed revision to be a user-friendly, NAP compliant, and meaningful governing document for CCPU.

The bylaws committee members are current and former officers and committee chairmen who bring with them a wealth of experience. The perspective of their experience adds tremendous value to our discussions. The committee has just begun review of the standing rules. The current debate is where officer duties and committee duties should go - - in the bylaws or the standing rules. What do you think?
